



SENIOR RESIDENT DOCTOR, GOLD COAST UNIVERSITY HOSPITAL

Dr Dinesh Palipana OAM is a senior resident doctor at Gold Coast University Hospital. Despite facing numerous barriers, he became the first quadriplegic medical graduate and medical intern in Queensland. He was recently admitted as a lawyer.

As co-founder of Doctors With Disabilities Australia, Dinesh has worked with the Australian Medical Association to create first-of-kind national policies for inclusivity in medical education and employment. Dinesh is a doctor for the Gold Coast Titans physical disability rugby league team. He is also a member of multiple committees for disability advocacy and has spoken in world-renowned forums such as TEDx. Through COVID-19, he advocated for equitable treatment for people with disabilities, including as a witness to the Disability Royal Commission.

Dinesh has also contributed significantly to scientific advances in treating spinal cord injury and restoring function to people with paralysis. His national and global impact has been recognised with numerous awards, including Junior Doctor of the Year and the Order of Australia.

Professor Clair Sullivan

UQ DIGITAL HEALTH CENTRE

Professor Clair Sullivan is an internationally recognised leading practising and academic clinical informatician, and is helping drive digital health transformation in Queensland.

Clair is Director of UQ's Queensland Digital Health Centre, a collaboration across UQ and major Australian and international partners. She is a Consultant Endocrinologist at Metro North Hospital and Health Service. Clair serves on several national advisory boards for digital health and has generated \$66M in funding. Clair is widely published in clinical informatics and is ranked in the top 1% of Medical Informatics researchers globally.

In 2024, Clair was appointed as the inaugural Professor of Digital Health at the University of Queensland. Clair's work has been recognised with multiple honours including a 2022 Telstra Brilliant Women in Digital Award. She chairs the Australian Council of Senior Academic Leaders in Digital Health.

SUPREME COURT OF QUEENSLAND, COURT OF APPEAL

Justice Boddice is a graduate of The University of Queensland – Bachelor of Laws (Honours) (1983). In 1984 Justice Boddice was admitted as a barrister of the Supreme Court of Queensland and appointed Senior Counsel in 2001.

His Honour previously served as a member of the Queensland Anti-Discrimination Tribunal (2006–2009), chair of the Queensland Nursing Tribunal (2007–2009), director (1993–2010) and chairperson (2006–2010) of Barristers' Chambers Limited, junior vice president (2006–2008), senior vice president (2008–2010) of the Medico-Legal Society of Queensland and member of the Continuing Professional Development Committee of the Bar Association of Queensland (2007–2009). Justice Boddice has been the legal patron of the Medico-Legal Society of Queensland since 2014.

Justice Boddice was appointed a judge of the Supreme Court of Queensland on 2 July 2010. Justice Boddice served as an additional Judge of the Mental Health Court from 2011 to 2014 and as President of that Court from 2014 to 2017.

Justice Boddice was appointed the Southern Region Judge of the Land Appeal Court in 2020. Justice Boddice was appointed a judge of the Queensland Court of Appeal in 2023.


